### Thoughts from Father Peter Pabst, S.J. ...

My kids are golfers! 23 boys and girls from the schools trek up to San José Country Club to participate in Northern California Golf Association Foundation's *Youth on Course*. This program introduces young people to the game, not only the physical part pertaining to swinging a club but to the etiquette involved in the game. Hopefully, there is a lesson on patience in the 20 sessions they receive. Here are some comments from the youth:

*"Each person might do something in a different way, but they all have the same goal: to get the ball in the hole."* Jocelyn, eighth grade

*"It's very relaxing. I come tired with a lot of thoughts on my mind that bother me. I focus on my arms and legs and swing and forget about everything. No distractions."* Oscar, eighth grade

I'm grateful to Patrick Quinn (Bellarmine '83) who referred us to the NCGA Foundation and the golf professional, Marc Baraga at SJCC, for all the coordinating he has done.

We have other great opportunities for students. A few weeks ago 18 girls went to the Cupertino campus of **Apple Computer** for a workshop, *Girls in Tech*. This was a continuation of a program for some of the girls that started when they attended Washington Elementary school. Before our Christmas break the 8th graders will go to **Cisco** for a career fair that will be given by some Latino and Latina employees who will help our boys and girls understand the different professions out there in the tech world. I believe they will also be able to see Cisco's revolutionary TelePresence Conference Room in action. I can't wait to see how this works!

Besides our 10.5 hour school day, another intervention we offer our students is our Saturday School program. Some Saturdays we use for catch up work in reading or writing. Other Saturdays we travel to San Francisco, Monterey, Santa Clara University or local parks to hike, tour and make use of the resources at our fingertips.

Sacred Heart Nativity Schools' work is about the education of the whole person. The more exposure our kids get to extraordinary parts of the community and Silicon Valley the more they grow. The more they are challenged, whether it is trying to get a ball into a small hole, walking across the Golden Gate Bridge, or imagining working at Cisco, the better it is for them. They are blest to have these experiences, and we are blest to have people wanting to support us in these unique ways.

Thank you for your support in our endeavor to empower the lives of the young to imagine themselves doing great things. If they can imagine it, they can do it. Thanks for working with us as we *break the cycle of poverty through education*.

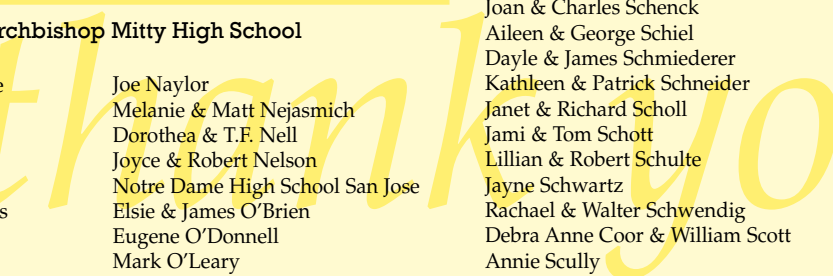

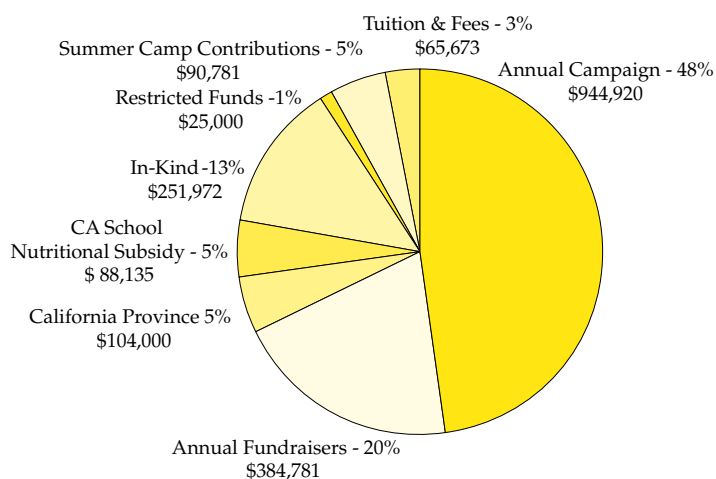

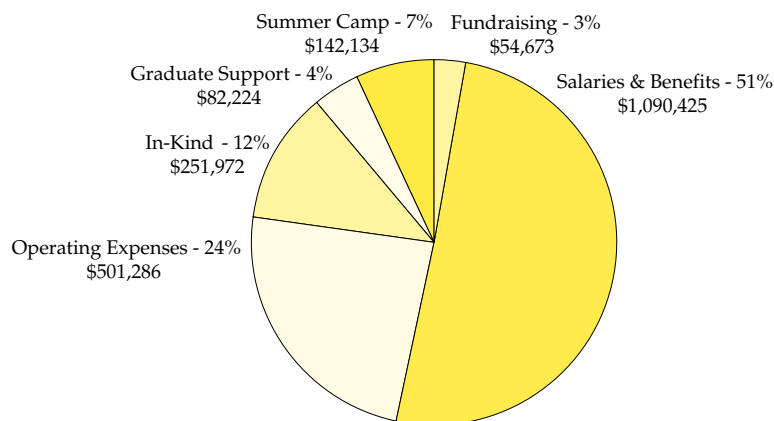
