

ACADEMIC ACHIEVEMENTS

The school is aligned in the mission of **educating students for future success**, and the cultural climate is one of **growth and possibilities**. Meeting students where they are is the starting goal upon admission, and continues throughout their academic journey. Technology is used in the classroom to enhance learning in all subject areas.

Student achievement is measured frequently through various modes of assessment including standardized testing. Many students enter the school testing below grade level in Language Arts and Math, but after three years of Nativity instruction, the average 8th grader scores at an 8.1 grade level in Language Arts and a 10.2 grade level in Math.

Faculty are trained to focus on differentiated instruction in support of English Language Learners. This includes technology integration and a range of teaching methods so that all students within a classroom can learn effectively, regardless of differences in ability.





ENRICHMENT ACTIVITIES

At Nativity, we care for the **"whole person"** and offer numerous co-curricular clubs and activities to enrich learning outside the classroom. High school volunteers from Bellarmine, Notre Dame, Mitty, Saint Francis and Presentation tutor our students and run clubs such as Robotics, Coding, and Chess.

Opportunities to move and increase students' physical activity are provided in many ways including Folklorico dance, yoga, volleyball, basketball, and Physical Education classes. Public speaking and debate skills are developed through our speech and debate club. Students also participate in SPEAK (Student Pursuit of Equality, Advocacy, and Kinship) to increase their awareness of social justice issues as well as to promote self-care. All of these opportunities provide a window of exposure for our students as they prepare for their next journey to high school!

FAITH IN ACTION & CAMPUS MINISTRY

Giving back to our community is paramount to the Nativity service program. Students live their faith daily by becoming young men and women for and with others through service opportunities offered throughout the year. Students deliver blessing bags (toiletries/prayer card) to clients served by Martha's Kitchen and Dignity on Wheels, work with students from the Morgan Autism Center, read with seniors at the Willow Glen Senior Center, and participate in neighborhood and school beautification projects.

The Campus Ministry program is led by our resident Jesuit and Jesuit Volunteer and provides **inclusive opportunities** for our students, faculty, and staff to nurture their faith and strengthen the sense of community at our school.

GRADUATE SUPPORT— THE 12-YEAR JOURNEY

Nativity becomes a "home away from home" for our students. The 12-year journey starts in 5th grade and continues through college. The Graduate Support Program embraces both students and parents by addressing the barriers that prevent low-income, first-generation college-bound students from attaining success. Program highlights include:

- Comprehensive high school placement planning with all 8th graders and their families
- Programming and curriculum are designed to prepare students for the transition to high school
- Summer meetings are held with students and families to ensure each student is prepared for orientation, registration, and classes
- Connections are made with 9th graders and families in the first weeks and months of school to ensure successful transitions

Their school day is longer than most, they attend monthly Saturday enrichment programs, and they only get one month off for a summer break. But, at the end of their three years, they are able to test at or above grade level, and most are accepted into private college preparatory high schools.

And through all the hard work and long hours, the students have grateful hearts, and truly appreciate the opportunities that Sacred Heart Nativity Schools afford them.

The average annual household income of our families is \$29,000, so they can only afford to pay 2% of the cost to educate their students. Therefore, we must raise \$20,000 per student to cover costs.
